Renewal scholarships will be awarded on the basis of academic status, co-curricular achievement and good citizenship, the same criteria used the first year you applied for a scholarship. Once selected, a student maintaining a cumulative grade point average of at least 2.75 or a "B-", or in the absence of a similar grading system, remains in "fine academic standing" as indicated by official record will be eligible to apply for a renewal of this scholarship for up to three additional years. Application for renewal is solely the responsibility of the student. All renewal applications are to be postmarked **no later than April 1** to:

To the extent of the scholarship awarded, trust funds will be paid to the institution which the recipient is attending, or to the recipient if the recipient provides the Committee with a paid receipt from the institution which the recipient is attending.
