Churchwide Representative

In his role, Iain works with congregations and communities as they address the church's biggest challenges of today while generating a path forward for the future. He believes the church can be part of positive change and likes to hear the stories of the creative ways people make that happen.

Iain has served with the ELCA Churchwide Organization over the past six years in a variety of roles, including as

Manager for Network Engagement with ELCA World Hunger. During his time with ELCA World Hunger, he worked with a network of over 2,500 congregational leaders across the ELCA working toward a just world where all are fed. Iain is a graduate of North Park University, Chicago, Illinois (biblical studies and history) and enjoys watching or playing soccer and exploring local restaurants.

Rules of Procedure for the Delaware-Maryland Synod Assembly

- 1. All voting members shall be invited to join the Zoom call through which the business of the Assembly will be conducted beginning one (1) hour in advance of each business session.
- 2. All participants in the Assembly will be permitted to either turn their camera on, or leave their camera off, during each business session. However, registered voting members must turn their camera on during any vote using ElectionRunner to digitally ensure that they are the one voting on the question at-hand.
- 3. The privilege of voice (on any issue before the Assembly), but not vote shall be granted to:
 - a. The presiding bishop of the ELCA and such other official representatives of this church as may be designated from time to time by the Church Council;
 - b. The chairpersons of synodical mission teams and task forces who are not voting members of the Synod Assembly; and
 - c. The president or president's appointee of the synodical youth, women's and men's organizations, and those additional persons whom the Synod Assembly or the Synod Council shall from time to time designate.
- 4. The privilege of voice and vote shall be granted to any leader rostered in a church body with which the ELCA is in full communion and who serves in a Delaware-Maryland Synod congregation or ministry.
- 5. In addressing the chair, speakers shall identify themselves by name and congregation, agency, or institution. To facilitate personal introduction and identification, all voting members shall include their congregation/affiliation name with their name as it appears on Zoom.
- 6. No person shall speak more than twice on the same question, except by consent of the assembly, and only after all others have spoken.
- 7. A member who has spoken on the pending question(s) may not move the previous question(s) at the conclusion of his/her speech. A motion to end debate by moving the previous question shall apply only to the immediately preceding motion. A motion to end debate on all matters on the floor or more than the immediately pending question is not in order.
- 8. A member may not move a previous question until the opportunity is available for five pro and five con points of view to be presented.
- 9. When a substitute motion is made, secondary amendments may be offered first to the original motion. After all secondary amendments to the original motion have been disposed of, secondary amendments to the substitute motion may be offered. When all amendments to the substitute motion have been disposed of, the vote shall be taken on whether the substitute motion is to be substituted as the original motion or be rejected.

- 10. The question shall be automatically called after thirty (30) minutes of debate unless the assembly consents to an extension of time.
- 11. In all business meetings, speeches from the floor shall be limited to two minutes.
- 12. All motions, other than routine ones, shall be presented verbally by the mover to the presiding officer, with a written copy provided for the secretary. To submit the written copy of a motion, registered voting members must use this form for the motion to be considered. Other forms of communication, such as a Zoom chat or email, will not be considered valid for presenting a motion.
- 13. To speak on a motion or amendment, any registered voting member of the Assembly must first use the "Raise Hand" function on Zoom. After their raised hand is noted, a member of the Assembly 2021 Technology Team will message them privately in the Zoom Chat to ask whether they intend to make a pro statement, con statement, or point of order when speaking. To ensure a balance between speakers for an amendment or motion, the Technology Team will organize raised hands into a que and unmute speakers accordingly.
- 14. When there are many pro and con statements on any motion or amendment, the chair will recognize alternately persons making a pro or con statement. This shall be done by alternating between those speaking "for" and those speaking "against" on the Zoom call. Those persons proposing a subsidiary motion should wait in que.
- 15. If three (3) speakers have spoken in favor of a motion with no one speaking against, the chair may proceed to call for the vote on the motion.
- 16.Only voting members shall be permitted to access online ballots for voting. Voting members shall be able to access their online ballot upon an election by utilizing their individualized voting credentials on ElectionRunner. Voting members must turn on their camera while a vote takes place.
- 17. No motion is before the house until it is stated by the chair, and no discussion shall occur without a motion before the assembly.
- 18. For elections other than bishop, additional nominations may be made from the floor for all positions except for conference-cluster based positions on the Synod Council, the youth position on the Synod Council, Mission Team Leaders, and the Dean on Synod Council. Those making such nominations must:
 - a. Obtain the consent of the person being nominated.
 - b. Ensure the nomination fulfills the category assigned for that purpose.
 - c. Complete a nomination form (which can be accessed <u>here</u>, or on the 2021 Synod Assembly webpage on our synod's website) before 5:30 p.m. on June 4, 2021.
- 19. Amendments to the budget may not increase total expenditures. Amendments changing one line item must be reflected in an equivalent change in other line item(s) so that total expenditures remain constant. Anyone suggesting an amendment must complete a form which spells out the rationale for the

proposed change. The form can be found here or on our synod's website.

20. The minutes of this Synod Assembly shall be referred to the Synod Council for certification.

<u>Robert's Rules of Order</u>, latest edition, shall be the governing parliamentary procedure of this assembly, except as otherwise provided in the constitution, bylaws, and continuing resolutions of this synod and in these rules of procedure of the Synod Assembly, unless otherwise ordered by the assembly.

Memorials and Resolutions

Resolution 2021-1: To Create an Emergency Fund for Candidates Awaiting a First Call

- WHEREAS, 16% of eligible first call candidates in 2019 waited on a call for over a year across the Evangelical Lutheran Church in America (ELCA)^[1], and
- WHEREAS, 21% of pastoral candidates of color waited longer than one year for a first call that same year, and
- WHEREAS, candidates who identify as part of the LGBTQIA community often wait even longer than one year, with candidates of color within the LGBTQIA community waiting the longest out of all eligible candidates, and
- WHEREAS, candidates awaiting first call often cannot support themselves with supply preaching, often resorting to minimum-wage job opportunities or taking out additional student loans on top of the significant loans already accrued as a means of financial support;
- THEREFORE BE IT RESOLVED, that the Delaware-Maryland Synod of the ELCA create an emergency fund of \$5,000 to be used as financial support for candidates awaiting a first call; and
- BE IT FURTHER RESOLVED, that this fund will be managed by the Leadership Team of the Delaware-Maryland Synod; and
- BE IT FURTHER RESOLVED, that this fund will become a line item budget within the Leadership Team's annual budget, submitted to and approved by the Delaware-Maryland Synod Council as part of the annual budget process.

Vice President's Report

John Auger

To say that it has been a year like no other would be a gross understatement! Our worlds were locked down, turned upside down and shaken to the core. I think it would be safe to say that perhaps even our faith was shaken. If not shaken, at a minimum, perhaps jostled about.

Despite the challenges of the past year, I would like to focus on how our Synod has been called by God to "do a new thing". In fact, called to do many "new things". Most of these "new things" we wouldn't have done if it wasn't for the changes forced upon us by the pandemic.

Inspired by the words of Winston Churchill "we didn't waste a good crisis".

Our Bishop, Synod Staff, Vision Team Leaders and Synod Council leaders stepped bravely into the gap. Our Pastors, Deacons, Council Presidents and lay leaders went way beyond their job descriptions and did many new things and did them well.

I am proud to say that your Synod's leaders "ran towards the fire, not away", as courageous leaders do. In my conversations with these leaders, we all agreed, that none of us signed up for this.

We have been working to become adaptive leaders over the past several years. No year in recent memory has required adaptive leadership more than the past one. We thank God for preparing us with the tools we needed.

I continue to be both honored and privileged to work with these leaders as we move forward on the Holy Spirit's mission and vision for our Synod – **Being Called Together - Making Disciples for Jesus.**



I have been impressed and awed by how these leaders have responded with faith, grace, creativity, tenacity and humor to the challenges that we faced together. Synod means "walking together". I think this past year we not only walked together, but we held each other up. We loved, supported, comforted and did the hard work together that was needed to carry out God's calling.

I would like to focus on three brief examples to prove my point. Our Vision Team leaders - Linda Chinnia, Ron Fairchild, John Nelson and Daniel Mambu – will give you many more in their reports.

The first example is the involvement and connection of our Synod's lay leaders. Over the years we have struggled to identify, and then connect, our Synod's lay leaders in ways that are both helpful and supportive. Trying to do this face to face has been a big challenge. When the pandemic came along we had the opportunity to reach out and connect with each other virtually. We now have contact information for over 450 lay leaders in our Synod. Using that contact information we have been able to reach all of them with helpful information and updates to help them lead through the storm. We started connecting every other week via Zoom last May to share ideas and support each other. Very early the request came to have a separate call for our Council Presidents, so we started that in June. As of this May we have had 18 Lay Leader's and 15 Council President's Forums. We have now settled into a monthly schedule. The connections and sharing among these leaders "who didn't sign up for leading through a pandemic" has been both inspirational and transformational. We are looking to build upon these new connections as we empower and develop more lay leaders.

The second example is your **Synod Council**. During the past year, we seamlessly transitioned to a virtual presence. Our meetings continue to be Spirit-filled, empowering and energizing. During this time we have asked ourselves how we best lead our Synod forward. We have dug deep in how we can be leaders in championing racial justice. We read *White Fragility* by Robin DiAngelo together and have been guided by Cathy Rice and Pastor Lura Groen, leaders of the Racial Justice Task Team, in how we can best implement changes to move our Synod forward. We also have been exploring how we can best empower and involve youth and young adults in our ministry efforts. We read the book *Growing Young* by Powell, Mulder and Griffin and have been led by Deacon Julie Stecker and Adam Fairchild in exploring strategies to improve in this area. All this while continuing to keep the Holy Spirit's mission and vision of *Being Called Together – Making Disciples in Jesus' Name* in front of us.

The final area that I would like to cover is **generosity**. A year ago when the extent of the pandemic was beginning to sink in, a lot of us were concerned about how our Synod's, and each congregation's, financial picture would shape up. We began to prepare for what we thought could potentially be a significant reduction in mission and other financial support. We were reminded again that we serve a God of abundance, not scarcity! God provided for us in amazing ways! Through the generosity of each of you and your congregations we were able to raise \$349K for the COVID Relief Fund, \$206K for the Synod Local Ministry Fund, as well as over \$1.6 million of mission support from our congregations. Our expenses were lower than expected, and with the help of the PPP loan we received, we actually had a surplus in our Faith Spending Plan of over \$100K. God promises that the resources will be provided if we keep focused on the goal of making disciples in Jesus' name. This past year was yet one more example of that promise.

In summary, this past year has been a challenge for us all. I have seen God at work through us in ways that are both amazing and inspiring. I thank all of you for your efforts and for "keeping the faith" despite the challenges. I know that we are better and stronger as a result.

These words of wisdom ring true: "You can't do it alone. So don't pretend you can. Together is better." I can tell you that we're more together now, than ever, as leaders and as a Synod. The Creator of the Universe is walking beside us cheering us on! Well done, good and faithful servants. May God continue to bless and keep you all!

This past year, I served as a co-Leader-Among-Leaders for the LYO Music Team. This year was absolutely crazy for everyone, not just my team. Other LALs and I discussed new ways for the LYO to continue to be active and impactful aside from retreats and events, which

had all been called off for the safety of everyone involved. The Music Team, in particular, traditionally worked throughout the year to learn new music, bond as a team, and prepare for large group sessions at retreats. With none of that happening this year, we figured out a way to remain productive and active – recordings. We created 'chains' in which an instrumentalist would start by recording just the basic chords for the song, then would pass it on to other instrumentalists and then to vocalists. It was a time consuming process, but it was worth it, and we now have more than ten completed chains that were available for use by churches in the synod in their own virtual services.

The LYO was not the only place where I learned to adapt. My home church closed down at the start of the pandemic due to the fact that so many of our members were at a high risk. Worship itself has always been one of the most valued things by our congregation, so not being able to worship on Sunday mornings was pretty difficult. However, if someone told me a year ago that my church would be livestreaming worship, which is now partially back to being in person, every Sunday, I would have laughed at them (from six feet away and through a mask, of course). To my Spring-2020-self's amazement, here we are a year later, doing everything we can to go back to 'normal' and worship the way we love, and we have God's grace to thank for that.

Churchwide Assembly is a place where connections are made. The Delaware-Maryland Synod is not the only synod there; over a thousand people are in attendance, not just making decisions but also making friends. A few years ago, I was in Houston, Texas for the 2018 ELCA Youth Gathering. Over 30,000 people were there, and the mass-gatherings were held in a literal football stadium. I was honestly amazed. Throughout this gathering, my group, as well as many other groups, had 'tradeables.' These ranged from clothespins to stickers to rubber bracelets. Throughout the gathering, whether that be on the train or on service day or anywhere else, we traded

various items with people from all over the country. Some people included their social media handles on their tradeables, others wrote down where they were from. I still have a bag of tradeables from the gathering. I talked to so many interesting people and groups, and I can't imagine how cool it would be if I see some of the same people at the next gathering in Minneapolis next year!!

Report of the Bishop

The Rev. William (Bill) Gohl Jr., Bishop

And your ancient ruins shall be rebuilt;
you shall raise up the foundations of many generations;
you shall be called the repairer of the breach,
the restorer of streets to dwell in.
- Isaiah 58.12

When we gather for our Synod Assembly, on-line, it will be the first time in nearly two years many of us will have seen each other. For those of us who see something of an ecclesiastical family reunion in our gathering, it's been a long time since we were last together at the Delta Hunt Valley in 2019. While grateful for the blessing of still being connected, I miss you – and I miss seeing you – and being together in our worship, fellowship, learning and service.

It was the best of times, it was the worst of times...

Leadership – If the Covid pandemic has taught me anything, it has taught me this: thank goodness that we've spent much of our time together and learning these last years around issues of adaptive leadership. I continue to be confounded and amazed by the ways our congregations and ministries, our deacons, pastors and lay leaders have all pivoted – many times over – to meet the challenges and changes of the pandemic. Even in the midst of the pandemic, our ministry teams and my staff colleagues have arranged for supportive check-ins and cohorts, coaching, training around a myriad of opportunities from new methods of tending the culture of generosity to digital evangelism. Our Racial Justice Team leveraged the pandemic time to call us together for a Lenten Learning Series. Our Creation Care Team invited us to dig deeper into the Earth Charter. Our Candidacy Committee is working with over 30 people in various stages of discernment! I look back over the last year and, while keenly aware of our many losses, I am amazed by God's grace at work in our ministries.

Discipleship – Our LYO and Youth+Family Ministries pivoted, too. When we couldn't gather for large events in person, we broke into small groups online. Our LYO Elementary Team helped curate ongoing community for our youngest Lutherans via a teaching series. We partnered with our siblings in the Metro DC Synod to expand our reach and Youth+Family resources as Deacon Julie became shared staff in both synods. While our Churchwide Organization was having to adjust to the changing

mission development landscape, our synod began the ELCA's only new mission in the midst of the pandemic – North Ave Mission, and found ourselves quickly on the front lines addressing the inequities of food security and stable housing. North Ave Mission, while quite special, embodies a spirit I saw across the synod as our congregations gathered resources, worked with the community and saw that our neighbors were fed, housed, had PPE, and children were supported even as schools were meeting online. There was not a day in 2020 when your support and partnership didn't make a difference in the lives of many.

Communication – Wasn't this the year when the church came kicking and screaming into modern technology? Our Communications Team offered training, technical support and some micro-grants. In a scant few months, even as our synod produced online worship for over six months including Lenten midweek, Holy Week and special services for All Saints, Youth Sundays, Christmas Lessons and Carols, the King Commemoration, and the Sunday after Easter, our congregations and ministries went online, and managed in-person, parking lots, drive-in and hybrid services, too. We had to plan the work – metrics, positivity rates, when to open/when to close – and work the plan, so that we moved forward together. We learned new ways of connecting with our people with phone-trees, daily devotions, care ministries; bringing Advent bags and Lent bags, Christmas candles, Ash Wednesday ashes, Palm Sunday palms, and Holy Communion to one another.

Connectedness – Your generosity allowed us to fund a Covid Relief Fund, connecting us to one another with resources to support technology, relief and operations in our congregations. With Mar-Lu-Ridge our synod produced a Vacation Bible School online! Our Hunger Task Force helped us with matching grants to make sure our neighbors' food insecurities were met in ways that make sense contextually. Practice Discipleship made space for our young adults to stay connected and to "retreat" online and at Mar-Lu-Ridge. We connected lay leaders and Congregation Council Presidents in cohorts led by Synod Council Vice President John Auger, we gathered our Rostered Ministers and Seminarians online regularly for information sharing and checking-in. Our synod staff, though in the midst of transition, have been "out and about" online and in-person so that call processes continue (21 completed during the pandemic), shared ministry training and support was provided, and relief was offered to ministries and ministers experiencing Covid fatigue and stress. We are stronger together, and that has become more clear week by week as we've journeyed through the "lentiest Lent" and this pandemic.

Faithful, yet changing...

The question I am regularly asked as I make my way around our synod and this church is: *What will the church look like after Covid?* While I have many theories and thoughts, none of us really know. I suspect that in-person attendance for worship and learning are going to take a hit – even as our online presence and connection will continue a trajectory of growth. I believe that congregations and ministries that leveraged the pandemic time to be creative in connecting and caring for those in their fellowship will see renewed strength in their communities. I believe that the culture of generosity we've seen in so many places will continue as we present a clear and urgent mission, model an attitude of gratitude, and tell the story of God at work in us and through us. Change is not the opposite of faithfulness, and real faithfulness will compel us to change. To be honest, I've never been more convinced that in Christ the best is still to come.
